On the 13th August 2010 Central Bedfordshire Council made a Road Traffic Regulation Order as follows:

Effect of the Order:

Introduce No Waiting at Any Time on the following lengths of road in Flitwick:

- 1. Temple Way: South side from a projected line with the rear flank wall of No 1 Eagle Drive in a north easterly direction for a distance of approx 29 metres (to the existing restrictions).
- 2. Steppingley Road: South west side from a point 21 metres north west of the property boundary between No 4 / No 5 Bluebell Close in a north westerly direction for a distance of approx 24 metres.
- 3. Manor Way: South east side from a point approx 1 metre north east of the property boundary between No 2 / No 3 Bluebell Close in a north easterly direction to the junction with Stepplingley Road (in line with the back of the footway).
- 4. Manor Way: North west side from a point approx 3.5 metre north east of the south west flank wall of No 12 Chaucer Road in a north easterly direction to the junction with Stepplingley Road (in line with the back of the footway).
- 5. Station Road: North side from the property boundary between No 89 / No 91 Station Road in a southerly and westerly direction for a distance of approx 42 metres.

<u>Date of Operation:</u> The Order will come into operation on the 27th August 2010.

<u>Further Details</u> of the Order and plans showing the lengths of road affected may be examined during normal opening hours at the Flitwick Library, Coniston Road, Flitwick.

<u>High Court Challenge:</u> Any person who desires to question the validity of the Order or of any provision contained therein on the ground that it is not within the powers of the relevant Section of the Road Traffic Regulation Act 1984 or on the ground that any requirement of that Section had not been complied with in relation to the Order may, within six weeks of the 19th August 2010 make application for the purpose to the High Court.

- This Order shall come into operation on 27th day of August 2010 and may be cited as "Central Bedfordshire Council (Bedfordshire County Council (District of Mid Bedfordshire) (Civil Enforcement Area and Special Enforcement Area) (Waiting Restrictions and Street Parking Places) (Consolidation) Order 2008) (Variation No 10) Order 2010"
- As from the date upon which this Order comes into operation, the provisions of the "Bedfordshire County Council (District of Mid Bedfordshire) (Civil Enforcement Area and Special Enforcement Area) (Waiting Restrictions and Street Parking Places) (Consolidation) Order 2008" shall be varied as follows:-
 - (i) The plan schedule reference "Area Code AA 85: Sheet Revision Number 2 shall be deleted and Area Code AA 85: Sheet Revision Number 3" shall be substituted.
 - (ii) The plan schedule reference "Area Code AA 86: Sheet Revision Number 3 shall be deleted and Area Code AA 86: Sheet Revision Number 4" shall be substituted.
 - (iii) The plan schedule reference "Area Code AB 88: Sheet Revision Number 3 shall be deleted and Area Code AB 88: Sheet Revision Number 4" shall be substituted.
 - (iv) The plan schedule reference "Area Code AD 88: Sheet Revision Number 2 shall be deleted and Area Code AD 88: Sheet Revision Number 3" shall be substituted.
