 - (i) The plan schedule reference "Area Code F114: Sheet Revision Number 1" shall be added to the plans attached to the Order.
 - (ii) The plan schedule reference "Area Code D115: Sheet Revision Number 1" shall be added to the plans attached to the Order.
 - (iii) The plan schedule reference "Area Code E115: Sheet Revision Number 1" shall be added to the plans attached to the Order.
 - (iv) The plan schedule reference "Area Code F115: Sheet Revision Number 1" shall be added to the plans attached to the Order.
 - (v) The plan schedule reference "Area Code D116: Sheet Revision Number 1" shall be added to the plans attached to the Order.
 - (vi) The plan schedule reference "Area Code E116: Sheet Revision Number 1" shall be added to the plans attached to the Order.
 - (vii) The plan schedule reference "Area Code E117: Sheet Revision Number 1" shall be added to the plans attached to the Order.

On 15th July 2011 Central Bedfordshire Council made a Road Traffic Regulation Order as follows:

Effect of the Order:

To introduce No Waiting At Any Time on the following lengths of road in Leighton Buzzard and Heath & Reach:

- 1. Both sides of Linslade Road from a point approximately 20 metres north-east of its junction with The Stile, Heath & Reach in a south-westerly direction to its junction with Bragenham Lane/Plantation Road.
- 2. Both sides of The Stile, Heath & Reach from its junction with Linslade Road in a southeasterly direction for a distance of approximately 12 metres.
- 3. Both sides of Bragenham Lane from its junction with Old Linslade Road/Linslade Road in a north-westerly direction for a distance of approximately 398 metres.
- 4. Both sides of Plantation Road from its junction with Old Linslade Road/Linslade Road in a south-easterly direction to a point approximately 20 metres south-east of its junction with Heath Court.
- 5. Both sides of Heath Court from its junction with Plantation Road in a south-westerly direction for approximately 16 metres.
- 6. Both sides of Old Linslade Road from its junction with Bragenham Lane in a generally south-westerly direction for a distance of approximately 249 metres.

<u>Date of Operation:</u> The Order will come into operation on the 22nd July 2011.

<u>Further Details:</u> of the Order and a plan may be examined during normal opening hours at Leighton Buzzard Library, Lake Street, Leighton Buzzard, LU7 1RX.

<u>High Court Challenge:</u> Any person who desires to question the validity of the Order or of any provision contained therein on the ground that it is not within the powers of the relevant Section of the Road Traffic Regulation Act 1984 or on the ground that any requirement of that Section had not been complied with in relation to the Order may, within six weeks of the 15th July 2011 make application for the purpose to the High Court.
