- This Order shall come into operation on 23rd day of July 2012 and may be cited as "Central Bedfordshire Council (Bedfordshire County Council (District of Mid Bedfordshire) (Civil Enforcement Area and Special Enforcement Area) (Waiting Restrictions and Street Parking Places) (Consolidation) Order 2008) (Variation No.19) Order 2012"
- As from the date upon which this Order comes into operation, the provisions of the 'Bedfordshire County Council (District of Mid Bedfordshire) (Civil Enforcement Area and Special Enforcement Area) (Waiting Restrictions and Street Parking Places) (Consolidation) Order 2008' shall be varied as follows:-
 - (i) The plan schedule reference 'Area Code AC 75: Sheet Revision Number 1" shall be deleted and 'Area code AC 75: Sheet Revision Number 2" shall be substituted.

On 16th July 2012 Central Bedfordshire Council made a Road Traffic Regulation Order as follows:-

To introduce Prohibition of Waiting on the following lengths of road in Ampthill:-

- 1. Chandos Road, north side, from its junction with Dunstable Road in a westerly direction to a point approximately 5 metres west of the front wall of no.82 Dunstable Street.
- 2. Chandos Road, south side, from its junction with Dunstable Road in a westerly direction to a point approximately 5 metres west of the front wall of no.82 Dunstable Street.
- Dunstable Street, west side, from the boundary of nos. 84 and 86 Dunstable Street in a southerly direction to the boundary of nos. 78a and 76c Dunstable Street.

Note: The Notice of Proposals published on 16th February 2012 included proposals to introduce a Prohibition of Waiting (double yellow lines) on longer lengths of Chandos Road, but these will NOT be implemented at this time.

Date of Operation:- The Order will come into operation on the 23rd July 2012.

<u>High Court Challenge:-</u> Any person who desires to question the validity of the Order or of any provision contained therein on the ground that it is not within the powers of the relevant Section of the Road Traffic Regulation Act 1984 or on the ground that any requirement of that Section had not been complied with in relation to the Order may, within six weeks of 16th July 2012, make application for the purpose to the High Court.
