Bedfordshire County Council (District of Mid Bedfordshire) (Civil Enforcement Area and Special Enforcement Area) Waiting Restrictions and Street Parking Places) (Consolidation) (Variation No 1) Order 2008

On the 19th September 2008 Bedfordshire County Council made a Road Traffic Regulation Order as follows:

Effect of the Order:

A. To make legal the existing Disabled Persons' Parking Place at the following location in Flitwick:-

On the south east side of Kendal Drive at a point approx 7 metres from the centre line of it's junction with Grasmere Close in a north easterly direction for a distance of approx 7 metres.

The days and hours of operation of this parking place will be unrestricted for disabled persons' vehicles.

The implementation of this Disabled Persons' Parking Place will result in the removal of the existing No Waiting 1.15pm to 6pm Monday to Friday restriction that is currently in operation on the length of road identified above.

The creation of this parking place is considered necessary to enable a disabled person to park at a convenient location close to their home.

B. Introduce no waiting, 8.00am-12.45pm Monday to Friday inclusive on the following lengths of road in Flitwick:-

i. Derwent Rise: South side, from a point approx 8 metres from it's junction with Coniston Road (end of existing restrictions), westwards for a distance of approx 140 metres to its most easterly junction with Thirlmere Gardens.

ii. Derwent Rise: South side, from its most westerly junction with Thirlmere Gardens in a generally north westerly direction for a distance of approx 76 metres.

iii. Coniston Road: South side from the end of the existing waiting restrictions generally westwards for a distance of approx 187 metres, including cul-de-sac, to the western boundary of No 75.

iv. Thirlmere Gardens: East side from its junction with Derwent Rise southwards for a distance of approx 136 metres, including turning head.

C. Introduce no waiting, 1.15pm-6.00pm Monday-Friday inclusive on the following lengths of road in Flitwick:-

i. Derwent Rise: North side from a point approx 8 metres from its junction with Coniston Road west for a distance of approx 303 metres, including cul-de-sac.

ii. Coniston Road: North side from the end of the existing waiting restrictions for a distance of approx 153 metres.

iii. Thirlmere Gardens: West side from its junction with Derwent Rise southwards for a distance of approx 157 metres, including cul-de-sac, to a point approx 21 metres south of the junction with the cul-de-sac.

D. Introduce no waiting Monday – Friday 8am-10am on the following lengths of road in Flitwick:

- i. The Avenue – South east side from a point approx 5 metres north east of its junction with Brookes Road north eastwards for approx 28 metres (to the end of the lay-by).
- ii. The Avenue – South east side from a point approx 138 metres north east of its junction with Brookes Road for a distance of approx 52 metres (entire length of the lay-by).
- iii. Easton Road – South side from a point approx 94 metres east of its junction with Kingsmoor Close, for a distance of approx 24 metres (entire length of the lay-by).
- iv. Beaumont Road – South west side from the projected north-west side of No.31 south eastwards for approx 17 metres.
- v. Beaumont Road: South west side from a point 4 metres west of the projected south east side of number 18 north eastwards for approx 11 metres.

E. Revoke existing no waiting at any time:-

The Avenue – South east side from a point approx 5 metres north east of the junction with Brookes Road for a distance of approx 15 metres (end of existing restriction).

F. Revoke existing no waiting Monday – Friday 8.00am – 12.45pm:-

- i. The Avenue – South east side from a point approx 20 metres north east of its junction with Brookes Road north eastwards for approx 28 metres (to the end of the lay-by).
- ii. The Avenue – South east side from a point approx 138 metres north east of its junction with Brookes Road for a distance of approx 52 metres (entire length of the lay-by).
- iii. Easton Road – South side from a point approx 94 metres east of its junction with Kingsmoor Close, for a distance of approx 24 metres (entire length of the lay-by).

G. Revoke existing waiting limited to 2 hours, with no return for 1 hour, from 8am to 6pm Monday to Friday inclusive on the following lengths of road in Flitwick:-

- i. Beaumont Road – South west side from the projected north-west side of No.31 south eastwards for approx 17 metres.
- ii. Beaumont Road: South west side from a point 4 metres west of the projected south east side of number 18 north eastwards for approx 11 metres.

Date of Operation: The Order will come into operation on the 30th September 2008.

Further Details of the Order and a plan showing the lengths of road affected may be examined during normal office hours at County Hall, Bedford and at Flitwick Library, Coniston Road, Flitwick.

High Court Challenge: Any person who desires to question the validity of the Order or of any provision contained therein on the ground that it is not within the powers of the relevant Section of the Road Traffic Regulation Act 1984 or on the ground that any requirement of that Section had not been complied with in relation to the Order may, within six weeks of the 25th September 2008 make application for the purpose to the High Court.

The Council of the County of Bedfordshire ('the Council') in exercise of their powers under Sections 1(1), 2(1) to (3) and 4(2) and Part IV of Schedule 9 of the Road Traffic Regulation Act 1984 ("The Act") and of all other enabling powers and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 to the Act hereby makes the following Order: -

1. This Order shall come into operation on the 30th day of September 2008 and may be cited as "Bedfordshire County Council (District of Mid Bedfordshire) (Civil Enforcement Area and Special Enforcement Area) (Waiting Restrictions and Street Parking Places) (Consolidation) (Variation No 1) Order 2008"
2. As from the date upon which this Order comes into operation, the provisions of the "Bedfordshire County Council (District of Mid Bedfordshire) (Civil Enforcement Area and Special Enforcement Area) (Waiting Restrictions and Street Parking Places) (Consolidation) Order 2008" shall be varied as follows:-
 - (i) The plan schedule reference "Area Code AB 85: Sheet Revision Number – 2" shall be deleted from the plans attached to the Order and plan schedule reference "Area Code AB 85: Sheet Revision Number – 3" shall be substituted.
 - (ii) The plan schedule reference "Area Code AB 86: Sheet Revision Number – 2" shall be deleted from the plans attached to the Order and plan schedule reference "Area Code AB 86: Sheet Revision Number – 3" shall be substituted.
 - (iii) The plan schedule reference "Area Code AB 87: Sheet Revision Number – 2" shall be deleted from the plans attached to the Order and plan schedule reference "Area Code AB 87: Sheet Revision Number – 3" shall be substituted.
 - (iv) The plan schedule reference "Area Code AB 88: Sheet Revision Number – 2" shall be deleted from the plans attached to the Order and plan schedule reference "Area Code AB 88: Sheet Revision Number – 3" shall be substituted.
 - (v) The plan schedule reference "Area Code AC 86: Sheet Revision Number – 2" shall be deleted from the plans attached to the Order and plan schedule reference "Area Code AC 86: Sheet Revision Number – 3" shall be substituted.
 - (vi) The plan schedule reference "Area Code AD 86: Sheet Revision Number – 2" shall be deleted from the plans attached to the Order and plan schedule reference "Area Code AD 86: Sheet Revision Number – 3" shall be substituted.
