

**CENTRAL BEDFORDSHIRE COUNCIL (BEDFORDSHIRE COUNTY COUNCIL (DISTRICT OF MID BEDFORDSHIRE) (CIVIL ENFORCEMENT AREA AND SPECIAL ENFORCEMENT AREA) (WAITING RESTRICTIONS AND STREET PARKING PLACES) (CONSOLIDATION) ORDER 2008) (VARIATION NO.24) ORDER 2013**

**CENTRAL BEDFORDSHIRE COUNCIL (20MPH SPEED LIMIT ZONE) (HITCHIN STREET AND BONDS LANE, BIGGLESWADE) ORDER 2013**

On 25th February 2013 Central Bedfordshire Council made the above named Road Traffic Regulation and Speed Limit Orders as follows:-

**To introduce a Prohibition of Waiting on the following length of road in Biggleswade:-**

Hitchin Street	West side, from a point in line with the north flank wall of no.12 Hitchin Street in a northerly direction for a distance of approximately 10 metres.
Hitchin Street	East side, from its junction with Bonds Lane in a southerly direction to a point approximately 26 metres south of the north flank wall of no.12 Hitchin Street.

**To amend the Limited Waiting for 1 hour with no return within 1 hour Monday to Saturday 8.00am to 6.00pm to cover the following lengths of road in Biggleswade:-**

Hitchin Street	West side, from a point in line with the north flank wall of no.8 Hitchin Street in a southerly direction for a distance of approximately 14 metres.
Hitchin Street	West side, from a point in line with the north flank wall of no.12 Hitchin Street in a southerly direction for a distance of approximately 26 metres.
Hitchin Street	West side, from a point approximately 3 metres north of the boundary of nos. 20 and 22 Hitchin Street in a southerly direction for a distance of approximately 10 metres.

**To introduce a 20mph speed limit zone on the following lengths of road in Biggleswade:-**

Hitchin Street	From its junction with Market Square to its junction with Mill Lane.
Bonds Lane	From its junction with Hitchin Street in an easterly direction for a distance of approximately 78 metres.

**Date of Operation:-** The Orders will come into operation on the 4th March 2013.

**Further Details** of the proposal and plans may be examined during normal opening hours at Biggleswade Library, Chestnut Avenue, Biggleswade SG18 0LL.

**High Court Challenge:-** Any person who desires to question the validity of the Order or of any provision contained therein on the ground that it is not within the powers of the relevant Section of the Road Traffic Regulation Act 1984 or on the ground that any requirement of that Section had not been complied with in relation to the Order may, within six weeks of 25th February 2013, make application for the purpose to the High Court.

The Central Bedfordshire Council (the "Council") in exercise of the powers under sections 1(1), 2(1) to (3), 4 (2) and Part IV of Schedule 9 of the Road Traffic Regulation Act 1984 ("The Act") and all other enabling powers and after consultation with the Chief Officer of Police in accordance with Part III of schedule 9 to the Act, hereby makes the following Order:

1. This Order shall come into operation on 4th day of March 2013 and may be cited as "Central Bedfordshire Council (Bedfordshire County Council (District of Mid Bedfordshire) (Civil Enforcement Area and Special Enforcement Area) (Waiting Restrictions and Street Parking Places) (Consolidation) Order 2008) (Variation No.24) Order 2013"
2. As from the date upon which this Order comes into operation, the provisions of the "Bedfordshire County Council (District of Mid Bedfordshire) (Civil Enforcement Area and Special Enforcement Area) (Waiting Restrictions and Street Parking Places) (Consolidation) Order 2008" shall be varied as follows:-

The plan schedule reference "Area Code BH 49: Sheet Revision Number – 2" shall be deleted and "Area Code BH 49: Sheet Revision Number – 3" shall be substituted.
