On 3 March 2014 Central Bedfordshire Council made the above named Traffic Regulation Order as follows:-

## To introduce No Waiting at any time on the following lengths of road in Maulden:-

- 1. Ampthill Road, south side, from its junction with Silsoe Road extending in a westerly direction to a point in line with the boundary of Maulden Lower School and no.6a Ampthill Road.
- 2. Clophill Road, south side, from its junction with Silsoe Road extending in an easterly direction to a point approximately 16 metres west of the boundary of nos.1 and 2 Whiteman Court.
- 3. Clophill Road, north side, from its junction with Church Road extending in an easterly direction to a point approximately 4 metres west of the boundary of nos.2a and 2b Church Road.
- 4. Silsoe Road, both sides, from its junction with Ampthill Road extending in a southerly direction to a point approximately 9 metres north of the boundary of nos.4 and 5 Whiteman Court.
- 5. Church Road, east side, from its junction with Clophill Road extending in a northerly direction to the south flank wall of no.2a Church Road.

## <u>To introduce No Stopping Monday to Friday between 8.00am and 4.30pm on School Entrance</u> Markings on the following lengths of road in Maulden:-

- 1. Ampthill Road, north side, from its junction with Church Road extending in a westerly direction to a point in line with the boundary of Maulden Lower School and no.6a Ampthill Road.
- 2. Church Road, west side, from its junction with Ampthill Road extending in a northerly direction to a point approximately 7 metres south of the boundary of nos.2 and 4 Church Road.

<u>Date of Operation</u>:- The Orders will come into operation on the 10 March 2014.

<u>Further Details</u> may be examined during normal opening hours at Ampthill Library, 1 Dunstable Street, Ampthill MK45 2NL.

<u>High Court Challenge</u>:- Any person who desires to question the validity of the Order or of any provision contained therein on the ground that it is not within the powers of the relevant Section of the Road Traffic Regulation Act 1984 or on the ground that any requirement of that Section had not been complied with in relation to the Order may, within six weeks of 3 March 2014, make application for the purpose to the High Court.

  - (i) The plan schedule reference "Area Code AG 75: Sheet Revision Number 1" shall be added to the plans attached to this Order.
  - (ii) The plan schedule reference "Area Code AH 75: Sheet Revision Number 1" shall be added to the plans attached to this Order.
