(VARIATION NO.31) ORDER 2014

The Central Bedfordshire Council (the "Council") in exercise of the powers under sections 1(1), 2(1) to (3), 4 (2) and Part IV of Schedule 9 of the Road Traffic Regulation Act 1984 ("The Act") and all other enabling powers and after consultation with the Chief Officer of Police in accordance with Part III of schedule 9 to the Act, hereby makes the following Order:

1. This Order shall come into operation on 1st September 2014 and may be cited as "Central Bedfordshire Council (Bedfordshire County Council (District of South Bedfordshire) (Civil Enforcement Area and Special Enforcement Area) (Waiting Restrictions and Street Parking Places) (Consolidation) Order 2008) (Variation No.31) Order 2014"
2. As from the date upon which this Order comes into operation, the provisions of the "Bedfordshire County Council (District of South Bedfordshire) (Civil Enforcement Area and Special Enforcement Area) (Waiting Restrictions and Street Parking Places) (Consolidation) Order 2008" shall be varied as follows:-
 - (i) The plan schedule reference "Area Code AH 148: Sheet Revision Number – 2" shall be deleted and "Area Code AH 148: Sheet Revision Number – 3" shall be substituted.
 - (ii) The plan schedule reference "Area Code AI 148: Sheet Revision Number – 2" shall be deleted and "Area Code AI 148: Sheet Revision Number – 3" shall be substituted.
 - (iii) The plan schedule reference "Area Code Q 144: Sheet Revision Number – 1" shall be added to the plans attached to this Order.

On 25 August 2014 Central Bedfordshire Council made the above named Traffic Regulation Order as follows:-

Please note that the notices of proposals published on 6 May 2014 in relation to Caddington and on 20 February 2014 in relation to Eaton Bray contained additional length of no waiting and 2 hours limited waiting that will not be implemented at this time.

To introduce No Waiting at any time on the following lengths of road in Caddington:-

1. Dunstable Road, south-east side, from the north-east property boundary of no.1 Dunstable Road extending in a north-easterly direction to its junction with Manor Road.
2. Manor Road, west side, from the south-east kerb line of Dunstable Road extending in a generally south-easterly direction for a distance of approximately 16 metres, including approximately 3 metres into the northern end of the shops service road.
3. Manor Road shops service road, west side, from the south flank wall of no.7 Manor Road extending in a generally southerly direction for a distance of approximately 12 metres to Manor Road.
4. Manor Road, east side, from the south-east kerb line of Dunstable Road extending in a generally southerly direction for a distance of approximately 15 metres to the north end of the constructed lay-by.
5. Manor Road, west side, from a point in line with the south flank wall of The Cricketers public house extending in a southerly direction to its junction with Orchard Road.
6. Orchard Road, north side, from the west kerb line of Manor Road extending in a westerly direction for a distance of approximately 14 metres.

To introduce 1 hour Limited Waiting with No Return within 3 hours, Monday to Saturday 8am to 6pm, on the following lengths of road in Caddington:-

1. Manor Road, east side, for the full length of the constructed lay-by from a point approximately 15 metres south-east of the south-east kerb line of Dunstable Road extending in a southerly direction for a distance of approximately 30 metres.
2. Manor Road shops service road, west side, from a point in line with the south flank wall of no.7 Manor Road extending in a northerly direction for a distance of approximately 29 metres.

To introduce 2 hours Limited Waiting with No Return within 3 hours, Monday to Saturday 8am to 6pm, on the following lengths of road in Caddington:-

1. Manor Road, west side, from a point in line with the south flank wall of The Cricketers public house extending in a north-easterly direction for a distance of approximately 45 metres.

To introduce No Waiting at any time on the following lengths of road in Eaton Bray:-

1. High Street, north side, from a point in line with the boundary of nos.98 and 100 High Street extending in an easterly direction to a point in line with the boundary of no.100b and 102 High Street.
2. School Lane, both sides, from its junction with High Street to a point in line with the boundary of no.83 High Street and no.1 School Lane.

Date of Operation:- The Orders will come into operation on the 1 September 2014.
