BEDFORDSHIRE COUNTY COUNCIL (DISTRICT OF MID BEDFORDSHIRE) (CIVIL ENFORCEMENT AREA AND SPECIAL ENFORCEMENT AREA) WAITING RESTRICTIONS AND STREET PARKING PLACES) (CONSOLIDATION) (VARIATION NO 4) ORDER 2009

On the 13th March 2009 Bedfordshire County Council made a Road Traffic Regulation Order as follows:

Effect of the Order:

A. Introduce No Waiting at any Time on the following lengths of road in Flitwick:-

- i. Kingsmoor Close: On both sides of the bell mouth from a point 5 metres east of the eastern flank wall of the property No 17 in an easterly direction for a distance of 22 metres; and also from a point 2.5 metres south of the western corner of the property No 2 in a southerly direction for a distance of 8 metres.
- ii. Kingsmoor Close: On the southern side from a point 19 metres west of the western flank wall of the property No 6 in a westerly direction for a distance of 22 metres.
- iii. Kingsmoor Close: On the southern side from the western flank wall of the property No 6 in an easterly direction for a distance of 12 metres.

B. Introduce No Waiting, 8:00am to 6:00pm Monday to Friday inclusive on the following length of road in Flitwick:-

Kingsmoor Close: On the eastern side from a projected line from the southern flank wall of property No 12 in a southerly direction for a distance of 27 metres.

C. Introduce No Waiting, 8:00am to 9:00am and 3:00pm to 4:00pm Monday to Friday inclusive on the following lengths of road in Flitwick:-

- i. Kingsmoor Close: On the western side from the southern flank wall of property No 12 in a southerly direction for a distance of 27 metres.
- ii. Kingsmoor Close: On the southern side from the western flank wall of the property No 6 in a westerly direction for a distance of 19 metres.
- iii. Kingsmoor Close: On the southern side from a point 5 metres east of the projected line from the eastern flank wall of property No 17 in a westerly direction for a distance of 30 metres.

<u>D. Introduce No Stopping Monday to Friday inclusive from 8:00am to 6:00pm on School Entrance Markings on the following length of road in Flitwick:</u>

Kingsmoor Close: From a point 13 metres east of the boundary between property Nos 3 and 4 in a westerly direction for a distance of 32 metres.

Date of Operation: The Order will come into operation on the 23rd March 2009.

<u>Further Details</u> of the Order and a plan showing the lengths of road affected may be examined during normal office hours at County Hall, Bedford and Flitwick Library, Coniston Road, Flitwick.

<u>High Court Challenge:</u> Any person who desires to question the validity of the Order or of any provision contained therein on the ground that it is not within the powers of the relevant Section of the Road Traffic Regulation Act 1984 or on the ground that any requirement of that Section had not been complied with in relation to the Order may, within six weeks of the 22nd March 2009 make

application for the purpose to the High Court.

The Bedfordshire County Council (the "Council") in exercise of the powers under sections 1(1), 2(1) to (3), 4 (2) and Part IV of Schedule 9 of the Road Traffic Regulation Act 1984 ("The Act") and all other enabling powers and after consultation with the Chief Officer of Police in accordance with Part III of schedule 9 to the Act, hereby makes the following Order:

- This Order shall come into operation on 23rd day of March 2009 and may be cited as "Bedfordshire County Council (District of Mid Bedfordshire) (Civil Enforcement Area and Special Enforcement Area) (Waiting Restrictions and Street Parking Places) (Consolidation) Order 2008 (Variation No 4) Order 2009"
- 2. As from the date upon which this Order comes into operation, the provisions of the "Bedfordshire County Council (District of Mid Bedfordshire) (Civil Enforcement Area and Special Enforcement Area) (Waiting Restrictions and Street Parking Places) (Consolidation) Order 2008" shall be varied as follows:-
 - (i) The plan schedule reference "Area Code AC 86: Sheet Revision Number 3" shall be deleted and "Area Code AC 86: Sheet Revision Number -.4" shall be substituted.
 - (ii) The plan schedule reference "Area Code AC 87: Sheet Revision Number 2" shall be deleted and "Area Code AC 87: Sheet Revision Number 3" shall be substituted.
 - (iii) The plan schedule reference "Area Code BK 78: Sheet Revision Number 1" shall be added to the plans attached to the Order.

STATEMENT OF REASONS FOR THE MAKING OF A TRAFFIC REGULATION ORDER TO INTRODUCE WAITING RESTRICTIONS AND STREET PARKING PLACES IN KINGSMOOR CLOSE, FLITWICK

INTRODUCTION

Bedfordshire County Council has drawn up a proposal to make a Traffic Regulation Order to introduce waiting restrictions and no stopping restrictions in Kingsmoor Close, Flitwick.

LENGTHS OF ROADS CONCERNED

1. No Waiting at any Time on the following lengths of road:-

Kingsmoor Close: On both sides of the bell mouth from a point 5m east of the eastern flank wall of the property No 17 in an easterly direction for a distance of 21m; and also from a point 2.5m south of the western corner of the property No 2 in a southerly direction for a distance of 8m.

Kingsmoor Close: From a point 4m east of the boundary between property Nos 3 and 4 in an easterly direction for a distance of 9m.

2. No Waiting, 8:00am to 12:45pm Monday to Friday inclusive on the following length of road:-

Kingsmoor Close: On the eastern side from a projected line from the southern flank wall of property No 12 in a southerly direction for a distance of 27m.

3. No Waiting, 1:15pm to 6:00pm Monday to Friday inclusive on the following lengths of road:-

Kingsmoor Close: On the western side from the southern flank wall of property No 12 in a southerly direction for a distance of 27m.

4. No Stopping Monday to Friday inclusive from 8:00am to 6:00pm on School Entrance Markings on the following length of road:-

Kingsmoor Close: From a point 12m east of the western flank wall of the property No 6 in a westerly direction for a distance of 44m.

These proposals are shown on the plan BH/200239/DR/000/001/TRO

SUPPORTING DATA

The proposed Order is considered necessary on the grounds of promoting road safety. The restrictions are specifically aimed at keeping the junction clear of parked vehicles and restricting parking in the vicinity of Kingsmoor Lower School during school opening hours. If approved time limited restrictions will prevent all day parking by commuters but enable local residents and parents to utilise the space.

There is currently an advisory 'School Keep Clear' carriageway marking outside the entrance to Kingsmoor Lower School in Kingsmoor Close; however, enforcement cannot be carried out as there is no supporting Order. By introducing an Order on these markings and adding a timed restriction of no stopping, Monday – Friday 8am – 6.00pm, this can be enforced, which will improve road safety.
