THE COUNTY OF BEDFORDSHIRE (DISTRICT OF MID BEDFORDSHIRE) (CIVIL ENFORCEMENT AREA AND SPECIAL ENFORCEMENT AREA) (WAITING RESTRICTIONS AND STREET PARKING PLACES) ORDER 2008 (CONSOLIDATION) (VARIATION NO 5) ORDER 2009

On the 27th March 2009 Bedfordshire County Council made a Road Traffic Regulation Order as follows:

Effect of the Order:

A. Introduce no waiting at any time on the following lengths of road in Cranfield:-

(i) College Road: South side, from a point 35.5 metres west of the eastern flank wall of Mitchell Hall, Cranfield University, in a westerly direction for a distance of 80 metres.

(ii) College Road: South side, from a point 139.5 metres west of the eastern flank wall of Mitchell Hall, Cranfield University, in a westerly direction for a distance of 75.5 metres.

(iii) College Road: South and east sides, from a point 275 metres west of the eastern flank wall of Mitchell Hall, Cranfield University, in a westerly, then southerly direction for a distance of 208 metres.

(iv) College Road: North and west sides, from a point 35.5 metres west of the eastern flank wall of Mitchell Hall, Cranfield University, in a westerly, then southerly direction for a distance of 483 metres.

(v) University Way: Both sides for its entire length.

(vi) Lanchester Road: Both sides for its entire length.

<u>B. Introduce limited waiting Monday – Friday, 8am – 6pm for 1 hour, no return within 1 hour on the following lengths of road in Cranfield:-</u>

(i) College Road: South side, from a point 115.5 metres west of the eastern flank wall of Mitchell Hall, Cranfield University, in a westerly direction for a distance of 24 metres.

(ii) College Road: South side, from a point 215 metres west of the eastern flank wall of Mitchell Hall, Cranfield University, in a westerly direction for a distance of 60 metres.

Date of Operation: The Order will come into operation on the 6th April 2009.

<u>Further Details</u> of the Order and a plan showing the lengths of road affected may be examined during normal office hours at County Hall, Bedford and at Cranfield Post Office, Mill Road, Cranfield.

<u>High Court Challenge:</u> Any person who desires to question the validity of the Order or of any provision contained therein on the ground that it is not within the powers of the relevant Section of the Road Traffic Regulation Act 1984 or on the ground that any requirement of that Section had not been complied with in relation to the Order may, within six weeks of the 5th April 2009 make application for the purpose to the High Court.

- This Order shall come into operation on 6th day of April 2009 and may be cited as "Bedfordshire County Council (District of Mid-Bedfordshire) (Civil Enforcement Area and Special Enforcement Area) (Waiting Restrictions and Street Parking Places) (Consolidation) Order 2008 (Variation No 5) Order 2009"
- As from the date upon which this Order comes into operation, the provisions of the "Bedfordshire County Council (District of Mid-Bedfordshire) (Civil Enforcement Area and Special Enforcement Area) (Waiting Restrictions and Street Parking Places) (Consolidation) Order 2008" shall be varied as follows:-

(i) The plan schedule reference "Area Code I 56: Sheet Revision Number – 1" shall be added to the plans attached to the Order.

(ii) The plan schedule reference "Area Code I 59: Sheet Revision Number – 1" shall be added to the plans attached to the Order.

(iii) The plan schedule reference "Area Code I 60: Sheet Revision Number – 1" shall be added to the plans attached to the Order.

(iv) The plan schedule reference "Area Code J 56: Sheet Revision Number -1" shall be added to the plans attached to the Order.

(v) The plan schedule reference "Area Code J 57: Sheet Revision Number – 1" shall be added to the plans attached to the Order.

(vi) The plan schedule reference "Area Code J 58: Sheet Revision Number – 1" shall be added to the plans attached to the Order.

(vii) The plan schedule reference "Area Code J 59: Sheet Revision Number – 1" shall be added to the plans attached to the Order.
