CENTRAL BEDFORDSHIRE COUNCIL (DISTRICT OF SOUTH BEDFORDSHIRE) (CIVIL ENFORCEMENT AREA AND SPECIAL ENFORCEMENT AREA) (WAITING RESTRICTIONS AND STREET PARKING PLACES) (CONSOLIDATION) ORDER 2008 (VARIATION NO 9) ORDER 2010

On the 19th March 2010 Central Bedfordshire Council made a Road Traffic Regulation Order as follows:

#### Effect of the Order:

### A. To introduce No Waiting At Any Time on the following lengths of road:

- 1. Wing Road, Linslade, on the west side from a point approx 5m south of southern boundary of No 54A Wing Road in a southerly direction to the northern boundary wall of No 64 Wing Road, a distance of approx 18m.
- 2. Wing Road, Linslade, on the west side from approx 3m south of the southern boundary wall of No 68 Wing Road in a southerly direction to the boundary between Nos 86 & 88 Wing Road.
- 3. Wing Road, Linslade, on the east side from opposite Ship Road in a northerly direction to a point approx 13m north of the southern boundary of No 41 Wing Road.
- 4. Mentmore Road, Linslade, on both sides from its junction with Wing Road in a southerly direction to a point approx 15m south of the northern boundary wall of No 43 Wing Road, fronting Mentmore Road.

## B. To introduce footway/carriageway parking places (where 2 wheels of the vehicle are required to be located on the footway within the prescribed parking place – a maximum of 0.4m from the kerb) at anytime on the following lengths of road and footway:

- 1. Wing Road, Linslade, on the west side from the northern boundary wall of No 64 Wing Road south to approx 3m south of the southern boundary wall of No 68 Wing Road, a distance of approx 16m.
- 2. Wing Road, Linslade, on the west side from a point approx 5m south of southern boundary of No. 54A Wing Road north to a point 2m south of the northern boundary wall on No 44 Wing Road, a distance of approx 37m.

### C. Removal (revocation) of waiting restrictions on the following length of road:

Wing Road, Linslade, on the east side from a point approx 13m north of the southern boundary of No 41 Wing Road in a northerly direction to the northern boundary wall of No 29 Wing Road, a distance of approx 25m.

<u>Date of Operation:</u> The Order will come into operation on the 29th March 2010.

<u>Further Details</u> of the Order and a plan showing the lengths of road affected may be examined during normal office hours at the Customer Service Centre, Central Bedfordshire Council, Bossard House, West Street, Leighton Buzzard.

<u>High Court Challenge:</u> Any person who desires to question the validity of the Order or of any provision contained therein on the ground that it is not within the powers of the relevant Section of the Road Traffic Regulation Act 1984 or on the ground that any requirement of that Section had not been complied with in relation to the Order may, within six weeks of the 25th March 2010 make application for the purpose to the High Court.

- 2. As from the date upon which this Order comes into operation, the provisions of the "Bedfordshire County Council (District of South Bedfordshire) (Civil Enforcement Area and Special Enforcement Area) (Waiting Restrictions and Street Parking Places) (Consolidation) Order 2008" shall be varied as follows:-

The plan schedule reference "Area Code E 127: Sheet Revision Number – 1" shall be deleted and "Area Code E 127: Sheet Revision Number – 2" shall be substituted.
