(CONSOLIDATION) ORDER 2008) (VARIATION NO.47) ORDER 2016

The Central Bedfordshire Council (the "Council") in exercise of its powers under sections 1(1), 2(1) to (3), 4 (2) and Part IV of Schedule 9 of the Road Traffic Regulation Act 1984 ("The Act") and all other enabling powers and after consultation with the Chief Officer of Police in accordance with Part III of schedule 9 to the Act, hereby makes the following Order:

1. This Order shall come into operation on 15th day of February 2016 and may be cited as "Central Bedfordshire Council (Bedfordshire County Council (District of Mid Bedfordshire) (Civil Enforcement Area and Special Enforcement Area) (Waiting Restrictions and Street Parking Places) (Consolidation) Order 2008) (Variation No.47) Order 2016"
2. As from the date upon which this Order comes into operation, the provisions of the "Bedfordshire County Council (District of Mid Bedfordshire) (Civil Enforcement Area and Special Enforcement Area) (Waiting Restrictions and Street Parking Places) (Consolidation) Order 2008" shall be varied as follows:-

To add No Waiting at any time on the following length of road:-

- (i) Saunders Piece, Ampthill, south side, from a point approximately 1 metre west of the boundary of nos.22 and 23 Chiltern Close extending in a westerly direction for approximately 24 metres.
- (ii) Queens Road, Ampthill, west side, from a point in line with the boundary of nos.41 and 43 Queens Road extending in a southerly direction for approximately 17 metres.
- (iii) Queens Road, Ampthill west side, from a point approximately 15 metres south of the boundary of nos.21 and 23 Queens Road extending in a southerly direction for approximately 24 metres.
- (iv) The Square/Bedford Road, Aspley Guise, south side, from a point approximately 3 metres south-east of the boundary of nos.2 and 3 The Square extending in a generally easterly direction for approximately 36 metres.
- (v) West Hill, Aspley Guise, north-west side, from a point in line with the boundary of no.16 and 18 West Hill extending in a south-westerly direction to a point in line with the north-east property boundary of no.28 West Hill.
- (vi) West Hill, Aspley Guise, south-east side, from a point in line with the north-east flank wall of no.18 West Hill extending in a south-westerly direction to a point in line with the north-east property boundary of no.28 West Hill.
- (vii) Etonbury Academy layby adjacent to Stotfold Road, Arlesey, both sides, for its full extent.
- (viii) Drove Road, Biggleswade, west side, from a point approximately 2 metres south of the south flank wall of no.27 Drove Road extending in a northerly direction for approximately 20 metres.
- (ix) London Road, Biggleswade, south-west side, from a point approximately 13 metres south-east of the north-west flank wall of The Yorkshire Grey public house extending in a south-easterly direction for approximately 36 metres.
- (x) London Road, Biggleswade, south-west side, from a point approximately 25 metres north-west of the boundary of nos.144 and 146 London Road extending in a north-westerly direction for approximately 20 metres.

- (xi) Orchard Close, Gravenhurst, north-east side, from a point approximately 3 metres north-west of the boundary of nos.1 and 3 Orchard Close extending in a generally northerly direction for approximately 22 metres.
- (xii) Orchard Close, Gravenhurst, south-west side, from a point approximately 3 metres north-west of the boundary of nos.1 and 3 Orchard Close extending in a north-westerly direction for approximately 8 metres.
- (xiii) Greenfields (north section), Shillington, all sides, from a point in line with the boundary of nos.19 and 19a Greenfields extending in a clockwise direction across the front of the school to a point in line with the northern property boundary of no.25 Greenfields.
- (xiv) Bury Road, Shillington, west side, from a point approximately 3 metres south of the rear wall of no.11 Bedford Close extending in a southerly direction to a point approximately 6 metres north of the boundary of no.1 Woodmer Close and no.57 Bury Road.
- (xv) Bedford Close, Shillington, both sides, from the west kerb line of Bury Road extending in a westerly direction for approximately 16 metres.
- (xvi) Woodmer Close, Shillington, both sides, from the west kerb line of Bury Road extending in a westerly direction for approximately 15 metres.

To add No Waiting Monday to Friday from 8.00am to 4.30pm on the following length of road:-

- (i) Queens Road, Ampthill, west side, from a point approximately 17 metres south of the boundary of nos.41 and 43 Queens Road extending in a southerly direction for approximately 66 metres.

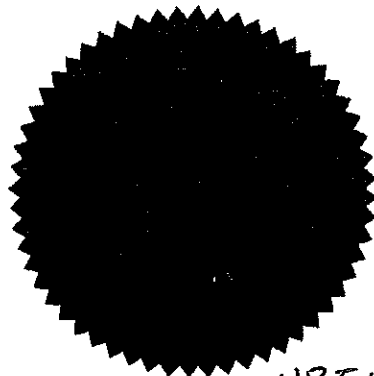
To add No Stopping Monday to Friday from 8.00am to 4.30pm on School Entrance Markings on the following lengths of road:-

- (i) Queens Road, Ampthill, west side, from a point approximately 39 metres south of the boundary of nos.41 and 43 Queens Road extending in a southerly direction for approximately 26 metres.
- (ii) Stotfold Road, Arlesey, south-west side, from a point approximately 30 metres south-east of the north-western end of the Etonbury Academy layby extending in a north-westerly direction for approximately 63 metres.
- (iii) Stotfold Road, Arlesey, south-west side, from a point approximately 24 metres south-east of the south-eastern end of the Etonbury Academy layby extending in a south-easterly direction for approximately 57 metres.
- (iv) London Road, Biggleswade, south-west side, from a point in line with the boundary of nos.144 and 146 London Road extending in a north-westerly direction for approximately 25 metres.
- (v) High Street, Gravenhurst, south side, from a point approximately 8 metres east of the boundary between no.8 High Street and Gravenhurst Lower School extending in a generally easterly direction in Orchard Close to a point approximately 8 metres north-east of the boundary of nos.1 and 3 Orchard Close.
