(CONSOLIDATION) ORDER 2008) (VARIATION NO.61) ORDER 2017

The Central Bedfordshire Council (the "Council") in exercise of its powers under sections 1(1), 2(1) to (3), 4 (2) and Part IV of Schedule 9 of the Road Traffic Regulation Act 1984 ("The Act") and all other enabling powers and after consultation with the Chief Officer of Police in accordance with Part III of schedule 9 to the Act, hereby makes the following Order:

1. This Order shall come into operation on 30th day of October 2017 and may be cited as "Central Bedfordshire Council (Bedfordshire County Council (District of Mid Bedfordshire) (Civil Enforcement Area and Special Enforcement Area) (Waiting Restrictions and Street Parking Places) (Consolidation) Order 2008) (Variation No.61) Order 2017"
2. As from the date upon which this Order comes into operation, the provisions of the "Bedfordshire County Council (District of Mid Bedfordshire) (Civil Enforcement Area and Special Enforcement Area) (Waiting Restrictions and Street Parking Places) (Consolidation) Order 2008" shall be varied as follows:-

To add No Waiting at any time on the following lengths of road in Cranfield:-

- (i) High Street, north side, from a point approximately 4 metres west of the boundary of nos.187 and 187b/187d High Street extending in an easterly direction to a point in line with the boundary of nos.2 and 4 Flitt Leys Close.
- (ii) Flitt Leys Close, east side, from its junction with High Street extending in a northerly direction to a point approximately 3 metres north of the north flank wall of no.6 Flitt Leys Close.
- (iii) Flitt Leys Close, west side, from its junction with High Street extending in a northerly direction to a point approximately 4 metres north of the rear wall of nos.187b/187d High Street.
- (iv) Flitt Leys Close, east side, from a point approximately 11 metres north of the north flank wall of no.6 Flitt Leys Close extending in a northerly direction for approximately 14 metres.
- (v) Flitt Leys Close, east side, from a point approximately 11 metres north of the boundary of nos.8 and 10 Flitt Leys Close extending in a northerly direction for approximately 13 metres.
- (vi) Flitt Leys Close, west and south sides, from a point approximately 11 metres north of the boundary of nos.8 and 10 Flitt Leys Close extending in a northerly then westerly direction for approximately 13 metres.
- (vii) Flitt Leys Close, west and north sides, from a point approximately 3 metres west of the boundary of nos.14 and 16 Flitt Leys Close extending in an easterly then northerly direction for approximately 13 metres.

To add No Waiting Monday to Friday between 8.30am and 4.30pm on the following lengths of road in Cranfield:-

- (i) Braeburn Way, south-west side, from a point approximately 5 metres north of the boundary of nos.18 and 20 Flitt Leys Close extending in a north-westerly direction for approximately 50 metres.
